Service provider panel session

Service Provider reference groups have been critical to the development and implementation of initiatives including the provider reporting portal and performance management framework. Consultation with service providers undertaken by Painted Dog Research recommended WAPHA increase engagement with commissioned service providers in the decisions that impact them.

A new Special Interest Panel for Service Providers was established in September 2022 with the aim to facilitate discussion with the sector and act as a sounding board for actions and change related to service providers and the commissioning cycle.

The Service Provider Special Interest Panel met for its first discussion session on Tuesday 8 November 2022. Participants represented a diversity of service size and type, with representation from all seven Country WA regions and Perth metro area.

Conversation was predominantly focused on cultural competency in the context of Aboriginal health and needs of Aboriginal people in the community and as employees.

State Government to ban LGBTIQA+ conversion practices in WA

The McGowan Labor Government has announced that it will move to criminalise practices that seek to change or suppress an individual's sexual orientation or gender identity.

Conversion and suppression practices are formal and informal practices that are based on the ideology that LGBTIQA+ people have a disorder and require treatment. They can include teachings, counselling, spiritual care activities, or other psychological or medical interventions.

The Premier commented that, "not only are conversion and suppression practices ineffective but they undermine the fundamental value of personal dignity and have long term negative impacts on the health and mental health of LGBTIQA+ people in our community".

LGBTIQA+ communities and the medical profession will be consulted as new laws are drafted.

Launch of the Parenting Education and Support Initiative

The Australian Government is funding a range of initiatives targeted at parents and carers to provide them with the knowledge and tools to understand support the social and emotional development of their children as they grow and develop.

In partnership with Triple P International Pty Ltd (TPI), the Australian Government is providing \$40.6m for the Parenting Education and Support Program (the Program) to deliver free, universal access to evidence-based, online parenting education and support to all Australian parents and carers with a child under 12 years.

The suite of parenting resources offered by TPI will enable parents and carers to develop the confidence, skills, and strategies required to better support child mental health and wellbeing as infants and children progress through the key development milestones, and help them identify potential problem behaviours early. The current program offering includes Triple P online under 12, Fear-less Triple P online and the new Triple P online for Babies.

TPI will also deliver a national communications campaign to build awareness of the Parenting Program, with a focus on reducing stigma around parents reaching out for support to nurture and assist the mental health and wellbeing of their children through the key developmental milestones in these years.
